Tenants on the Move at the Mound

The Mound Business Park welcomed additional tenants in 2014, while maintaining 100% client retention year over year.

Most recently, Dyrdek Group, Inc. purchased 790 Enterprise Court. Owned by Kettering native and MTV Star Rob Dyrdek, this marketing and creative services firm now owns a 5800 square foot space and is expected to take occupancy later this year.

At the end of 2014, the Mound Business Park also welcomed engineering and architectural services firm Barge, Waggoner, Sumner and Cannon to the property. They spent several months renovating their space at 1370 Vanguard Boulevard and added 12 full-time positions to their Dayton operations.

Tenant Excelitas expanded their lease, moving their executive management team from 1100 Vanguard Boulevard into a larger space on the fourth floor of 965 Capstone Drive.

This year, the Mound Business Park has partnered with Officer Hesler and Ohio Police Canines to provide the canines and their handlers with vacant space for training.

Together, Officer Hesler and the Mound Business Park worked out a plan for use of both green and indoor space within specific buildings. Ohio Police Canines includes units from all over Southwest Ohio, including a canine from the Miamisburg Police Department. Their handlers use the Mound to train canines in everything from detecting human odors to narcotics and explosives odors.

When I approached Eric about in-service canine training, he was more than accommodating," said Officer Hesler. "The use of the park not only allows the teams to flourish, but it also allows workers at the Mound and the general public to get a chance to watch what kind of work the teams do.

The people, the plant, their research, and manufactured items were at the leading edge of the Nuclear Age in the United States. Mound-built components are still in the U.S. nuclear weapons stockpile protecting us as a deterrent to attack from other nuclear powers. Moundbuilt components went with NASA to the moon, Mars and Jupiter, reliably powering their instruments and keeping them at operational temperatures. They are still continuing in the same vein to Saturn, the outer reaches of the solar system, and beyond.

At the end of last year, our partners at Chisano Marketing Group were acquired by another Miamisburg agency, Think Patented. Early in 2014, we worked with Chisano to re-brand from the Mound Advanced Technology Center to the Mound Business Park. This year we will continue and expand upon that work with Think Patented.
