

FORMER MIAMISBURG MAYOR DICK CHURCH APPOINTED ADMINISTRATOR FOR MOUND DEVELOPMENT CORPORATION, MOUND BUSINESS PARK

In 2020, Mound Development Corporation welcomed former Miamisburg Mayor Dick Church as the new Administrator for Mound Development Corporation and Mound Business Park. He joins Site Manager Lorrie Huber who has been with Mound Development Corporation for nearly eight years.

For 28 years, Dick Church served Miamisburg as Mayor. During that time, he championed Mound Business Park

as a cause in countless ways. From helping to secure \$1 Billion in funding to meeting with elected officials both locally and nationally, Church has been a critical component in the ongoing success of Mound Business Park.

"Former Mayor Dick Church lists the Mound's reuse as one of the top 3 accomplishments for Miamisburg during his tenure," said Miamisburg Public Information Officer Gary Giles. "He was a champion for the Mound's future throughout his career and was an ongoing presence in D.C. to advocate [for the Mound.]"

Just before Church was elected as Mayor of Miamisburg, the U.S. Department of Energy announced their plans to close what was then known as the Mound Laboratory. During his time as mayor, Church was heavily involved in the Mound's decommissioning, remediation, reuse plan, and ultimately the development of Mound Business Park.

This important work continues today as Mound Business Park continues to renovate, expand, and welcome new businesses to the property. Today, Mound Business Park is a place where 16 companies operate with more than 400 employees.





BLUEGRASS FARMACEUTICALS COMPLETES ADDITION OF LABORATORY SPACE

Bluegrass Farmaceuticals, LLC, a Kentucky health and wellness company, completed their expansion at 965 Capstone Drive within Mound Business Park. With their addition of new laboratory space, Bluegrass Farmaceuticals is now better equipped to continue the research and development of their extraordinary and unique health products.

In 2019, the company announced it had signed an exclusive partnership with 3x Grammy winner and iconic entertainer Nelly to create and market a proprietary line of sports performance beverages and other natural health products.

EXCELITAS COMPLETES 38,000 SQ. FT. EXPANSION AT MOUND BUSINESS PARK

In October of last year, Excelitas Technologies Corp. completed their 38,000 sq. ft. expansion at 1100 Vanguard Drive within Mound Business Park.

The scope of the project included adding additional office, laboratory, and manufacturing space to the existing Excelitas facility, expanding their footprint at Mound Business Park by 75%. This project allowed Excelitas to add production lines to accommodate additional contracts recently awarded.

Excelitas is a leading provider of photonic technology solutions. From their headquarters in Miamisburg, Excelitas provides defense and aerospace clients with innovative safety solutions.

Excelitas was one of the first businesses located at Mound Business Park and has been headquartered there for more than 25 years. Today, Excelitas occupies five buildings at Mound Business Park and is the Mound's largest employer.

Along with this expansion, Excelitas also committed to another 10 years at the property.

SECURE CYBER DEFENSE CONTINUES TO GROW AS CYBER ATTACKS BECOME MORE SOPHISTICATED

Secure Cyber Defense, LLC is a dedicated cybersecurity company providing Managed Detection and Incident Response services for manufacturing, financial services, education, DOD contractors, and State and local government clients. In 2019, the company leased an additional 5,000 square feet to accommodate additional employees, create a cybersecurity training area, and add a video production studio to support the development of cybersecurity training videos and webinars.

In December of 2020, Secure Cyber Defense was awarded a \$75,000 JobsOhio grant to employ and train 16 new employees over the next three years. The company was also recently granted a tax abatement from the city of Miamisburg aimed at retaining the company in Miamisburg and bringing new jobs to fuel further growth.

This year, Mound Development Corporation will also continue to focus on the 199 acres of shovel-ready land available at Mound Business Park.
